- Removal of the items should be completed within 30 (Thirty) days from the date of receipt of the Delivery Order. Items should be removed under strict supervision of the officer's represents from Railway Stores at Rathmalana, Railway Stores at Maradana and Railway Protection Force (RPF). Please note that delivery should be arranged without any damages to the Railway Properties.

05. The Security Bond will be returned only after successfully completion of the disposed item.
06. This Letter of Award, Railway Conditions of Contract together with your Bid dated **27.11.2023** and your acknowledgement to this letter of award and the Security Bond shall form a contract binding on both parties until such time a formal contract agreement is executed.
